

THE EXHIBITION - TERMS & GUIDELINES

(Organizer = Omnex AB on behalf of Swedish Rock Engineering Association, S.I.F = Stockholm International Fairs / Stockholmsmässan)

1 Terms of order

Booking of exhibition stand is done via an ordering form on the website www.omnex.se. Registration is binding and entails an obligation to pay corresponding fees to the Swedish Rock Engineering Association.

The organizer reserves the right to make adjustments in the distribution of the exhibition spaces that are conditioned by a rational use of the premises.

Sharing or trading all or part of the leased space is not permitted without prior consent of the organizer.

Exhibitor's cancellation of order does not entail exemption from the obligation to pay the fees, other than after written agreement with the organizer.

2 General terms

Exhibitors are obliged to follow the organizer's and S.I.F's instructions and regulations within the exhibition area. Exhibitors are obliged to submit to the changes in location and space that are called for by the circumstances.

The exhibition stand must not exceed the rented space in neither length, width nor height. Specified dimensions are approximate. For information on exact dimensions of the allotted space, requests for installations higher than 2,5 m or display of larger machines, exhibitors must contact S.I.F event service for information and permission.

Exhibitors are solely responsible for the cost of transport, set-up, dismantling, etc of their exhibit.

Installation of working machines (does not apply to personal computers or similar), construction of larger structures and / or painting is not allowed without prior agreement with the organizer and S.I.F.

Alcoholic beverages may not be served, used or stored within the premises of S.I.F other than those that may be served of the organizer. S.I.F's designated supplier has the exclusive right regarding all sales and serving of food and beverages in their premises. Exhibitors may not sell nor serve food or beverages. Sweets, snacks and samples are allowed. In case of questions or uncertainty about what is allowed, exhibitors should contact S.I.F.

S.I.F is responsible for the general cleaning in the premises, and exhibitors are responsible for the cleaning of their rented space.

The premises and equipment of S.I.F are insured against fire, and has liability insurance against third parties. The venue owner and organizer are not responsible for exhibitors' property or commitment. Exhibitors are solely responsible for having the necessary insurances regarding their commitments and their property.

Exhibitors are responsible for damages or loss caused by him or his representatives in the exhibition premises as well as damages or loss as a consequence of exhibitor's negligence.

S.I.F provides necessary security surveillance, but does not assume any responsibility for exhibited products or other equipment, nor insurance of any kind. The organizer accepts no responsibility for exhibited items or material.

3 In- and outloading

The exhibition area is available for inloading and construction 2022-03-22 from 13:00 to 17:00 o'clock. (Special agreement with S.I.F applies concerning display of larger machines.)

The exhibition stand may not be dismantled or otherwise removed during the conference (2022-03-23 - 2022-03-24 08:00-16:30 o'clock).

All exhibited items etc must be removed from the exhibition area 2022-03-24 no later than 20:00 o'clock, otherwise S.I.F will arrange for removal and the cost will be charged to the exhibitor.

4 Services provided by S.I.F

S.I.F contacts exhibitors with necessary information and offers about its services. Orders must be made well in advance before the event and are charged according to S.I.F's current price list or according to a quote. Orders must be received by S.I.F no later than 28 days before the day of access. Orders placed later than 28 days before the date of access will be charged with a surcharge of 30% of the current price list. Orders placed from the day of access are charged with a surcharge of 50% on the current price list. Cancellation of these services is possible up to 28 days prior to the event.

The organizer accepts no responsibility for agreements made between exhibitors and S.I.F.

5 Force majeure

In case of war, strike, special measures by the state, municipality, local authorities or similar, lockout, fire, pandemics or other similar circumstances the organizer may be forced to cancel or shut down the exhibition without being liable for any refunds nor responsibility for costs, loss or damage of any kind that exhibitors may suffer thereof.

6 Covid-19

Special terms as follows due to Covid-19. (Does not apply to S.I.F's services.)

If restrictions are in effect 45 days before (=2022-02-06) the conference, that makes it impossible to go through with the event, Bergdagarna will be postponed. Only an administrative cost of 1500 SEK excluding VAT will be charged to registered exhibitors (also note paragraph 4). In the event of restrictions imposed by authorities after 2022-02-06 Force Majeure applies.

7 Other

Photographing and film recording may take place during Bergdagarna, and may be published on the organizer's various websites and in other marketing channels.
